### 3. Presentation: Jane Waldock – Executive Officer- MTF – Victorian 2020 Budget - Transport Review

Jane presented a summary of the Victorian 2020 Budget. She referred to Timna Jacks' reporting, and also comments provided by former Yarra Councillor, Jackie Fristacky. Jane also highlighted the State Treasurer's proposed introduction of a new tax on E-vehicles, and that there has been discussion on this acting to discourage community members from purchasing E-vehicles.

Jane noted the continuing emphasis in all projects concerning job creation, and that this theme should continue to be revisited in advocacy from MTF members. She also noted the appeal of larger projects - with big budgets, but with less complex community engagement requirements. Local

government should continue to work on how we can help state authorities to deliver on these projects for which we need their funding.

Lastly Jane referred to the opportunity for councillors to be clear about what they wish to leave as their legacy from this term, and to be as specific as possible in the wording that gets included in the Council Plan, as this will guide their officers in delivering programs and projects for the next four years.

Members then discussed the type of projects they were looking to include in their Council Plans, based on their election platforms, and feedback from the community. This ranged from electrification of rail services to Mornington Peninsula, long needed improvement to bus services in several municipalities, to supporting the normalisation of e-vehicles.

#### 4. Strategic Transport Advocacy

Greg Day encouraged councillors to include transport ideas in their council plans, and recommended that councillors have regular meeting with their local MPs. Greg also noted that in the next two years (leading to the 2022 state election) we will see two further state budgets, and a federal election.

Greg stressed the importance of continued advocacy for buses, and pointed to the NSW 2020 budget announcement committing to e-buses.

#### 5. Treasurer's report

Treasurer Cr Anna Chen spoke to the August Treasurer's report, noting invoices of \$1,100 (Incl GST) for Greg Day's Aug/September services, and \$8,760.20 (inc GST) for Jane Waldock's executive officer services which had been considered and approved for payment by the Executive in October, and also noting approved payment of invoice for the update of the website from Greg Day's for \$1,100 (inc GST).

MOTION: That the Treasurer's report for August 2020, 2 invoices approved by Executive for payment and 1 pre-approved invoice be noted.
